Notes for completing the Disclaimer form

The disclaimer form must only be completed if you are happy for your child to manage their dietary requirements without needing a special medical menu. Please note that the school menu cannot be altered by any of the catering staff if you complete this form.

We would always recommend that your child has a special diet menu provided if your child has an allergy or intolerance to a food(s). However, we are aware that some foods are not on our menu or are not likely to be on our menus in the future e.g. mussels, lupin flour and hence you are able to manage your child's special diet without needing a special diet menu.
